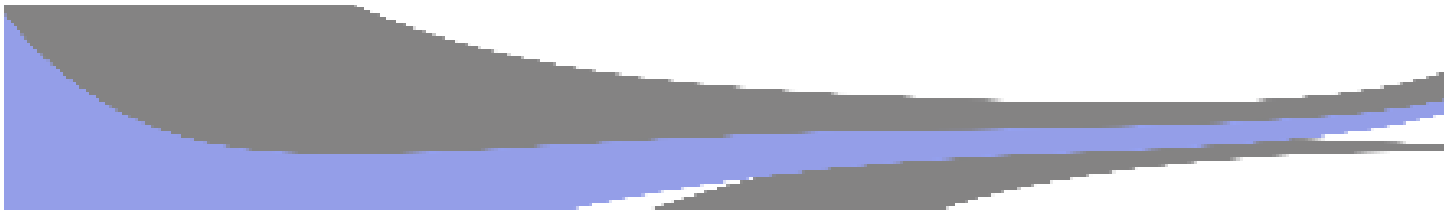

Live Learn and Lead - Client Agreement

Please carefully review the following information.

1. Session Duration and Pricing:

Our standard session duration is approximately 60 minutes. Current starting rates are:

- Individual Therapy: starting at \$30 per hour
- Family Therapy: starting at \$60 per hour
- Life Coaching: starting at \$40 per session

To encourage consistency and continued progress, sessions are scheduled in 6-week blocks. Participants are committing to their scheduled sessions for the full 6-week period.

Payment for the full 6-week block is due no later than the beginning of Week 4. All outstanding balances must be paid in full before another 6-week block may be scheduled.

2. Scheduling Sessions:

Consistency is an important part of building skills, independence, and progress. Participants are expected to attend their scheduled sessions throughout each 6-week block.

Please use the provided calendar to select and plan your session dates. We encourage families to schedule all sessions in advance to maintain a consistent day and time whenever possible.

If you need to cancel or reschedule, please contact Live Learn & Lead as soon as possible. No-call/no-show sessions will be considered used sessions and will not be credited or refunded.

3. Cancellation and Rescheduling

We understand that illness, emergencies, and unexpected circumstances may occur. If you need to cancel or reschedule a session, please notify Live Learn & Lead as soon as possible.

When adequate notice is provided, we will make every reasonable effort to reschedule the session based on availability. Missed sessions and no-call/no-show sessions are considered used sessions and will not be refunded or credited.

Repeated cancellations, missed sessions, or inconsistent attendance may result in the loss of your regularly scheduled time slot.

Consistent attendance is important for continued progress, skill development, and task independence.

4. Illness Policy

To help maintain a healthy environment for our participants, staff, volunteers, and animals, please notify Live Learn & Lead as soon as possible if you or your participant is ill and unable to attend a scheduled session.

Participants should not attend if they have a fever, vomiting, diarrhea, symptoms of a contagious illness, or are otherwise too unwell to participate comfortably and safely. If a participant stays home from school or work due to illness, we ask that they also stay home from their scheduled session at Live Learn & Lead.

We understand that illness happens. Sessions missed due to illness may be rescheduled based on availability when reasonable notice is provided.

5. Our Commitment

At Live Learn & Lead, we are committed to providing a safe, supportive, and encouraging environment where each participant can learn, grow, and build confidence at their own pace.

Our goal is to help participants develop practical life skills, social skills, independence, responsibility, and meaningful routines through individualized support and hands-on experiences.

We recognize that every participant has different strengths, needs, and goals. We will work with participants and their families to provide consistent support while encouraging continued growth and independence.

Important Information

Participants and/or their parent or legal guardian are responsible for determining whether the participant is physically able to safely participate in the activities offered. Participation therefore involves an inherent risk of injury.
